FleetRadar™ 5.3, from July 25th to August 29th, 2022

New & Improved

New single sign-on access to FleetConnected application via FleetRadar™

Customer access to FleetConnected is via FleetRadar™ and uses the new authentication protocol (MS-Azure B2C) released with FleetRadar™ 5.1:

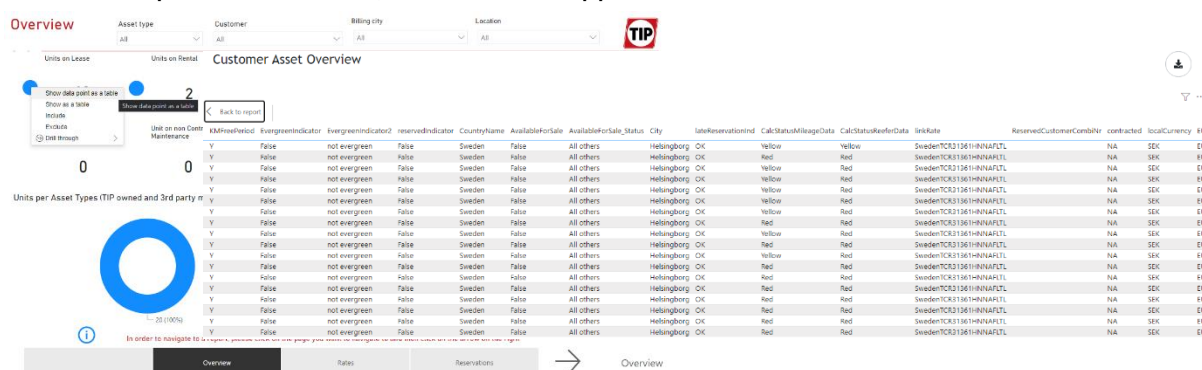
- A FleetConnected icon is visible on the top right menu bar of FleetRadar
- FleetConnected Users can access their customer tenancy by clicking the icon

The release is done customer by customer in 6 weekly batches (customer groupings) from July 25th to August 29th. All users from a given customer are transitioned to the new single sign-on access at the same time and are informed by email.

Improved Customer Asset Overview dashboard with additional data fields

Additional data fields are included in the Customer Asset Overview primary dashboard, a MS-powerBI dashboard on the home screen.

When right-clicking on any object in the Customer Asset Overview dashboard and selecting “Show datapoint as a table”, a table view appears.



This table view now includes 51 data fields including the following new ones:

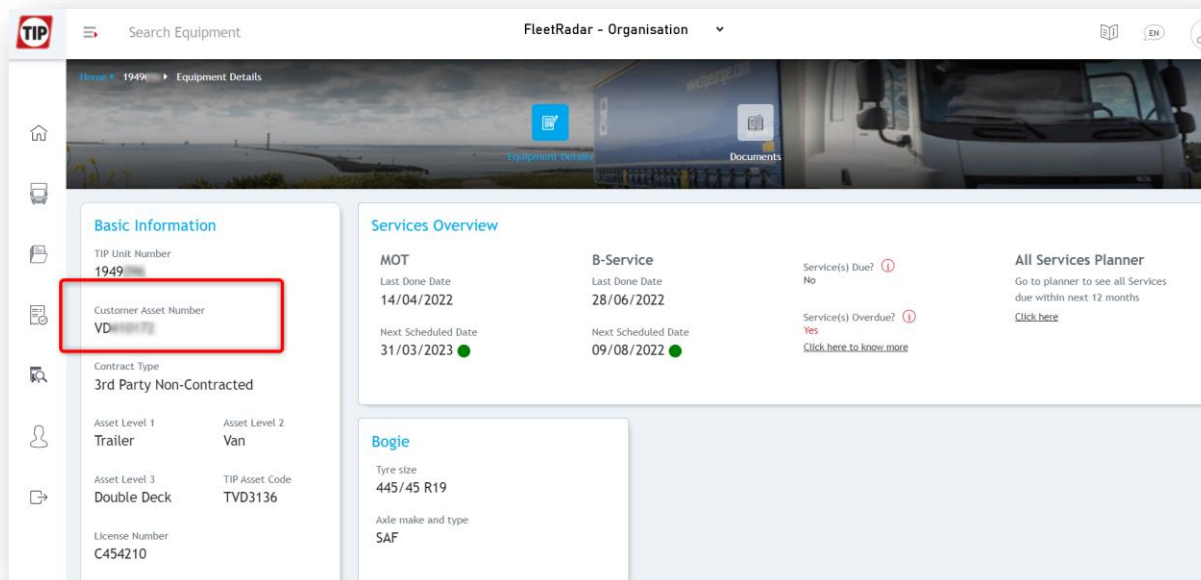
Actual mileage YTD, Contract free mileage allowance, Excess mileage rate, Customer livery status, Contract start date, Contract end date, Operational city, Reefer operating hours, Telematics rate and Telematics fitment status

New information has been added to the Equipment Details section

The Equipment Details section does now display “Customer Asset Number” information as an additional field in the *Basic Information* section. *



FleetRadar™ 4.1 enabled users to search assets by Customer Asset Number via the Quick Search functionality.

New authentication protocol: Microsoft Azure AD B2C

FleetRadar™ is now using Microsoft Azure AD B2C as its authentication protocol. Upon the first-time log-in after June 26th, **FleetRadar™** users will need to perform an account update (including email verification and password reset).

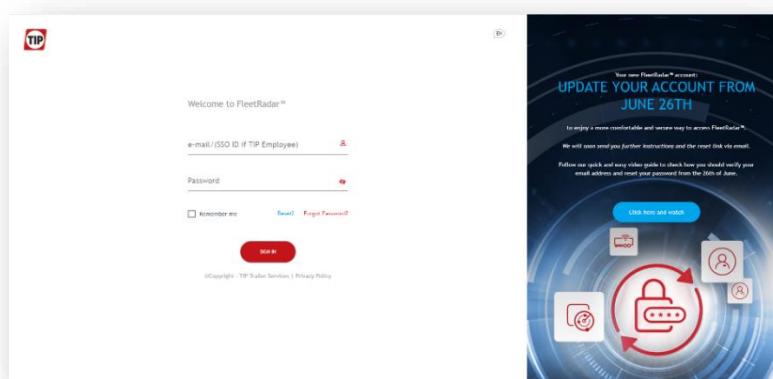

New information: Account update from June 26th



Improved vehicle inspection performance and user interface

Vehicle inspection application users can now access up to 25000 submitted vehicle inspection records. The records of submitted vehicle inspection reports can be accessed via the **FleetRadar™** Vehicle Inspection module. Please note, that the increased number of reports available might increase loading times.


1. Vehicle Inspection module navigation:
 - Pagination has been introduced (100 reports per page)
 - The total available number of reports is visible and the currently displayed ones
 - Responsive arrows lead to the next/previous page or to the very first/last page

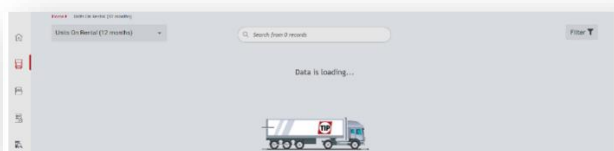

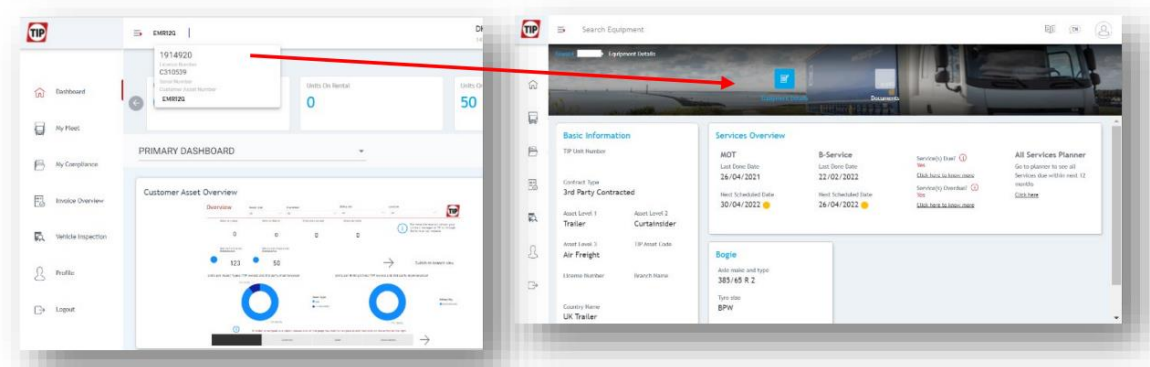

New search functionality: Customer Asset Number*

You can now search for a specific asset by Customer Asset Number. Clients who are sharing their own vehicle or fleet identification numbers assigned to assets on hire or maintained by TIP with a TIP representative, were already able to see the identification number per asset in the column “Customer Asset Number” in data tables (e.g., in My Fleet or My Compliance).

From now on, by entering the asset identifier in the top left search bar and clicking on the suggested asset, **FleetRadar™** will take you directly to Equipment details, from where you can also access asset related documents.

Introduction of a new *Help* section You can now access support materials, such as release notes and future support collaterals via the *Help* button on the top right menu bar.

Introduction of the *Invoice Overview Module*:

View paid and outstanding invoice information as new feature accessible via the left sidebar. You can access details of invoices or view all paid and outstanding invoices in one glance via a tabular view. Export functionality is available.

Introduction of *Primary Dashboards* to access standard reports created by TIP

1. Customer Asset Overview as Power BI embedded reporting tool

The Customer Asset Overview is a standard report providing you with complete fleet overview and enabling quick drill through to key datasets.

The report is made up of 3 tabs, 2 (*Fleet Overview* and *Reservations*) available to all users having a FleetRadar™ profile of “Fleet Manager” or “Contract Manager” + 1 additional tab (*Rates*) for users having a profile of “Contract Manager”.

The report is updated daily overnight.

The profile requires activation by your TIP contact before Admin users can activate it for fellow users.

Introduction of new fields in *Equipment details*

Contract Type: Rental/ Leasing / Unit on Contracted Maintenance / Unit on Non-Contracted Maintenance Contract Types have been added

- The Equipment high level breakdown: 3-Level breakdown of the asset: ie Trailer/Reefer/MultiTemp
- TIP Branch: showing the responsible TIP primary branch for this trailer

Introduction of new *Service Overview* section in *Equipment details*

1. Service Overview as new tab

Keep track of compliance events supported by country rules of due/overdue services.

- Last done date: shows last date executed for Compliance services (MOT and B-Service)
- Next scheduled date: shows Compliance next due date (MOT and B-Service)
- Traffic light system to visually provide sense of urgency for these main Compliance Types (MOT and B-Service)



Green: compliant, Amber: compliant, but service coming up soon, Red: service passed due

Introduction of FleetRadar™ standard functionality

Live tiles on the top inform about the current fleet status. Model dashboards load as standard and Fleet Overview Module accessible via the left sidebar to review 12 months of historic data on an asset level. The Compliance Overview Module helps you monitor upcoming and historic service events.

Service and asset related documents can be accessed and downloaded.
